2023 Annual Drinking Water Quality Report Big Creek Water System (0420009) April 2024

We're pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. Our water source is purchased from Anderson Regional Joint Water System (ARJWS) and the Greenville Water System. The ARJWS is supplied by surface water from the U.S. Army Corps of Engineer's Hartwell Lake Reservoir lying along the border of Upstate South Carolina and Georgia. The Greenville Water System, which is a combination of water from the Table Rock Reservoir treated at the Table Rock and North Saluda Filter Plant (DAF), and Lake Keowee treated at the Witty Adkins Water Treatment Plant. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Infants and young children are typically more vulnerable to lead in drinking water than the general population. If you are concerned about elevated lead levels in your home's water, you should flush your tap for 30 seconds to 2 minutes before using tap water. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Big Creek Water District is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Big Creek Water routinely monitors for contaminants in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2023 or the last required monitoring date. As water travels over the land or underground, it can pick up substances or contaminants such as

microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk. Water Quality Test Results Definitions

- ppm: Milligrams per liter or parts per million corresponds to 1 ounce in 7,350 gallons of water.

- ppb: Micrograms per liter or one part per billion corresponds to 1 ounce in 7,350,000 gallons of water.

- Action Level (AL): the concentration of a contaminant, which, if exceeded, triggers treatment or other requirements that a water system must follow.

-Action Level Goal (ALG): The level of a contaminate in drinking water below which there is no known or expected risk to health. ALG's allow for a margin of safety.

- *Maximum Contaminant Level or MCL*: The "Maximum Allowed" is the highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

- *Maximum Contaminant Level Goal or MCLG*: The "Goal" is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

-Maximum Residual Disinfectant Level Goal or MRDLG: The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLG'S do not reflect the benefits of the use of disinfectants to control microbial contaminants.

- *Maximum residual disinfectant level or MRDL*: The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of disinfectant is necessary for control of microbial contaminates.
